

April 5, 2018 Topgolf





## ORDINANCE NO.

ORDINANCE RELATING TO BOUNDARY CHANGES AND INCORPORATIONS; CREATING SECTION 20-0AMENDING SECTIONS 20-3, 20-3.1, 20-5, 20-6, 20-7, 20-22, 20-23 AND 20-29 OF THE CODE OF MIAMI-DADE COUNTY; THE DEFINITION OF AN ENCLAVE: MODIFYING REQUIRING MUNICIPALITIES PROPOSING TO ANNEX A PORTION OF THE UNINCORPORATED AREA TO PROVIDE INFORMATION RELATING TO THE MUNICIPALITY'S FISCAL AFFAIRS AND ADJACENT UNINCORPORATED AREAS; REQUIRING THE PLANNING ADVISORY BOARD COUNTY COMMISSION **CONSIDER** TO THE GUIDELINES RELATED TO (1) PROPOSED REVENUE-POSITIVE ANNEXATIONS AND INCORPORATIONS WHICH REVENUE-NEGATIVE/NEUTRAL CERTAIN EXCLUDE UNINCORPORATED AREAS OR ENCLAVES AND (2) IRREGULAR BOUNDARIES; REQUIRING THE COUNTY MAYOR OR MAYOR'S DESIGNEE, THE CLERK OF THE BOARD OF COUNTY COMMISSIONERS, AND THE PLANNING ADVISORY BOARD TO MAKE CERTAIN RELATED REPORTS, REFERRALS, RECOMMENDATIONS, DETERMINATIONS, AS APPLICABLE; WAIVING REQUIREMENT OF RESIDENT ELECTOR CONSENT FOR ANNEXATION CERTAIN MODIFICATION OF INCORPORATION PETITIONS AND MUNICIPAL ADVISORY COMMITTEE CONSENT FORMS; PROHIBITING APPROVAL OF CERTAIN ANNEXATIONS AND INCORPORATIONS **CERTAIN REVENUE-EXCLUDE** THAT NEGATIVE/NEUTRAL UNINCORPORATED **AREAS** ENCLAVES; PROVIDING FOR WAIVER SUCH OF PROHIBITION IN CERTAIN CIRCUMSTANCES

#### **RESOLUTION NO. 2018-2**

A RESOLUTION OF THE MIAMI-DADE LEAGUE OF CITIES OPPOSING PROPOSED MIAMI-DADE COUNTY ORDINANCE, DATED MAY 1, 2018, RELATED TO NEW PROCEDURES FOR MUNICIPAL INCORPORATIONS AND ANNEXATIONS, SPONSORED BY COMMISSIONER BARBARA JORDAN; URGING THE MUNICIPALITIES OF MIAMI-DADE COUNTY TO OPPOSE SAME; PROVIDING FOR TRANSMITTAL; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, many municipalities, neighborhoods, and geographic areas in Miami-Dade County (the "County") have, respectively, submitted applications for annexation or created Municipal Advisory Committees to pursue to incorporation or are interested in doing same; and

WHEREAS, the County has done numerous and extensive studies on both annexation and incorporations have done little to further the accomplishment of either; and

WHEREAS, the County also has a history of creating policy obstacles that make the pursuit and completion of annexation and incorporation efforts difficult; and

WHEREAS, County Commissioner Barbara Jordan, on May 1, 2018, presented to the Board of County Commissioners a substitute ordinance that created new procedures for municipal incorporations and annexations, which is attached hereto as Exhibit "A" (the "Ordinance"); and

WHEREAS, the Ordinance, which is to be applied retroactively and prospectively, establishes new procedural obstacles that further delay, entangle, and unduly prejudice pending and future annexation applications and incorporation efforts; and

WHEREAS, the Miami-Dade County League of Cities (the "League") has historically and consistently requested positive forward movement on both annexations and/or incorporations, by and through Resolutions Nos. 1995-12, 1998-08, 2000-10, 2002-01, 2002-3, and 2007-06; and

**WHEREAS**, the League opposes the Ordinance on the grounds that it creates undue burdens on municipal annexation applications and incorporation efforts.

NOW, THEREFORE, BE IT RESOLVED BY PRESIDENT JORDAN LEONARD AND THE BOARD OF DIRECTORS OF THE MIAMI-DADE LEAGUE OF CITIES, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.


Section 2. County Ordinance Opposed. The Miami-Dade League of Cities hereby opposes the proposed Miami-Dade County Ordinance, Dated May 1, 2018, related to new procedures for municipal incorporations and annexations, sponsored by Commissioner Barbara Jordan. The Municipalities of Miami-Dade County are encouraged to pass their own resolution against the Ordinance and to present during meetings of the Miami-Dade County Board of County Commissioner at which the Ordinance may be discussed.

Section 3. Transmittal. The City Clerk is hereby directed to transmit this Resolution to the Speaker of the Florida House of Representatives, the President of the Florida Senate, the Governor of the State of Florida, and such individuals of the Florida legislature and staff as deemed appropriate by the City Manager, to ensure that the City's position with this regard is clearly received and understood.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.

A RESOLUTION OF THE COMMISSION OF NORTH BAY VILLAGE, FLORIDA, CALLING ON THE STATE OF FLORIDA, GOVERNOR RICK SCOTT, PRESIDENT DONALD TRUMP, AND THE FEDERAL GOVERNMENT TO ENACT OR ADOPT LEGISLATION TO REDUCE GUN VIOLENCE BY REQUIRING A BACKGROUND CHECK FOR EVERY FIREARM SALE; SUPPORTING THE PASSAGE OF A RED FLAG LAW; RAISING THE MINIMUM AGE FOR THE LEGAL PURCHASE OF FIREARMS, MAGAZINES AND AMMUNITION TO TWENTY ONE (21); SUPPORTING THE PASSAGE OF LEGISLATION THAT WOULD KEEP MILITARY STYLE WEAPONS AND HIGH CAPACITY MAGAZINES AWAY FROM SCHOOLS; AUTHORIZING THE VILLAGE CLERK TO TRANSMIT THIS RESOLUTION; AND PROVIDING AN EFFECTIVE DATE. (INTRODUCED BY MAYOR CONNIE LEON KREPS, VICE MAYOR ANDREANA COMMISSIONER JOSE ALVAREZ, AND COMMISSIONER LAURA CATTABRIGA)

WHEREAS, gun violence affects all communities and easy access to firearms have created circumstances that have led to an unprecedented number of violent crime and mass shootings in American communities in recent years; and

WHEREAS, background checks are a central component of America's efforts to keep guns from criminals; and

WHEREAS, despite the fact that background checks are an effective means to prohibit gun sales to prohibited purchases, the system is undermined by legal loopholes and missing records that enable too many dangerous individuals to obtain weapons they later use in violent crimes; and

WHEREAS, under federal law, licensed gun dealers are mandated to conduct NICS checks before proceeding with a sale, but this requirement does not apply to so-called private sellers; and

WHEREAS, North Bay Village advocates common-sense policies that keep guns out of dangerous hands while respecting the rights of law-abiding gun owners and strongly believes that Congress and state governments should take action to close deadly gaps in the NICS; and

WHEREAS, easy access to military grade, high capacity magazine assault weapons have created circumstances which have led to an unprecedented number of mass shootings in American communities in recent years; and

WHEREAS, unlicensed persons may sell, deliver, or otherwise transfer a long gun or long gun ammunition to a person of any age; and

WHEREAS, in summary, with some exceptions, federal law prohibits the possession of a handgun or handgun ammunition by any person under the age of 18, but does not set a minimum age for the possession of long guns or long gun ammunition; and

**WHEREAS**, under Florida law, the purchase of a long gun is allowed for a person under 21 years of age; and

WHEREAS, in order to restrict such purchase and/or possession of a long gun, high capacity magazines and ammunition, the Florida legislature is required to amend Fla. Stat. § 790.17(2), 790.18; Fla. Stat. § 790.22(3), (5).

# FLORIDA LAW PUNISHES AND PROHIBITS ELECTED OFFICIALS FROM ENACTING LOCAL LEGISLATION TO REGULATE LAWS FIREARMS AND AMMUNITION


WHEREAS, in 1987, the Florida Legislature passed Chapter 87-23, Laws of Florida, which created Florida Statutes section 790.33 and declared the preemption of the area of regulation of firearms and ammunition, reserving the exclusive right to regulate and/or enforce any laws involving firearms and ammunition to the Florida Legislature and the State of Florida; and

WHEREAS, in 2011, the Florida Legislature passed and Governor Scott signed Chapter 2011-109, Laws of Florida to allow the Governor to remove from office, without due process of law, any person acting in an official capacity for a local authority, including an elected official, who passes an ordinance or causes to be enforced a local ordinance, administrative rule or regulation impinging on the exclusive authority of Florida legislature to regulate firearms and ammunition in all respects; and

WHEREAS, the 2011 Amendment to Florida Statutes section 790.33 provides for personal liability of any person who enacts or causes to be enforced any local ordinance impinging upon the Legislature's occupation of the whole field of regulation of firearms and ammunition; and

# NOW THEREFORE, BE IT RESOLVED BY THE COMMISSION OF NORTH BAY VILLAGE, FLORIDA:

- <u>Section 1</u>. The foregoing WHEREAS clauses are hereby ratified and incorporated as the legislative intent of this Resolution.
- <u>Section 2</u>. North Bay Village supports federal legislation that would require a background check for the purchase of every firearm.
- Section 3. North Bay Village urges the Florida legislature to immediately pass a "Red Flag Law" to protect our community from those who are identifiable as a threat to safety and security.
- Section 4. North Bay Village urges immediate amendment to Florida law to raise the age for legal purchase of guns, including long guns, high capacity magazines, and ammunition to 21 years of age.
- Section 5. North Bay Village urges the Florida legislature to repeal the punishments of elected officials set forth in Florida Statutes section 790.33.
- Section 6. The Village urges Florida Governor Rick Scott to take action to pass gun reform, even if it means extending the 2018 legislative session, to:
  - a. Raise the minimum age to allow the purchase of guns and ammunition to 21;
  - b. Eliminate the loopholes in the private transfer of weapons and require full background checks for all sales and transfers of firearms;
  - c. Repeal the prohibitions and penalties in Section 790.33(3), Florida Statutes;
  - d. Enact legislation regarding Red Flag Law to allow Extreme Risk Protection Orders;
- <u>Section 7</u>. The Village Clerk is hereby directed to distribute this Resolution to President Donald Trump, Governor Rick Scott, the United States Congressional Delegations from Florida, the Broward County Legislative Delegation, and the Miami-Dade League of Cities.
- <u>Section 8</u>. The Village urges immediate passage of legislation that would get military-style weapons and high-capacity magazines away from our community and especially our schools and that would increase the minimum age to purchase and possess a weapon from age 18 to age 21.
- Section 9. Effective Date. This Resolution shall be effective immediately upon its passage.
