President **Leonard** asked that Board Member Susie **Castillo**, Chief of Police Edwin **Lopez** and Associate Superintendent Ms. Iraida **Mendez-Cartaya** give us a report on the SRO's Memorandum of Understanding. Board Member Castillo spoke of partnering with the county government and various municipalities to increase the law enforcement presence at schools. Ms. Mendez-Cartaya explained that the primary mission of the SRO's is to support the Miami-Dade School Police Department by providing a visible deterrent to crime and a safe learning environment for all students and staff. For the school Board's fiscal year 2018-19, they will provide the municipality with funding in the amount of \$35,008 per school to complete the primary mission. Police Chief Lopez expressed that he hopes a vast majority of municipalities agree to partner with the district and guaranteed the safety of our schools if done so. Board Member Castillo, Chief Lopez and Associate Superintendent Ms. Iraida Mendez-Cartaya then offered to answer any questions or express concerns regarding the MOU.

RESOLUTION 18-047

A RESOLUTION OF THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, CALLING FOR A REFERENDUM TO BE HELD ON NOVEMBER 6, 2018 FOR THE PURPOSE OF SUBMITTING TO THE DULY QUALIFIED ELECTORS OF MIAMI-DADE COUNTY, FLORIDA A QUESTION REGARDING A LEVY OF AD VALOREM TAXES FOR OPERATING EXPENSES TO IMPROVE COMPENSATION FOR HIGH QUALITY TEACHERS, INSTRUCTIONAL PERSONNEL, AND TO INCREASE SCHOOL SAFETY AND SECURITY PERSONNEL, WITH OVERSIGHT BY A CITIZEN ADVISORY COMMITTEE; PROVIDING FOR PROPER NOTICE OF SUCH REFERENDUM; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, for the first time in the history of Florida School Performance Grades, the School District of Miami-Dade County, Florida ("the District") has achieved a district wide grade of an "A," and for the second year in a row, there are no "F"-rated traditional schools in the District; and

WHEREAS, higher percentages of Miami-Dade schools received "A" grades in 2018 than statewide across all schools and in all other large Florida Districts; and

WHEREAS, the District's graduation rate rose to 84.2 percent for the 2016-2017 academic year, the highest rate the District has achieved since the Florida Department of Education began tracking graduation statistics with modern methods in the late 1990s; and

WHEREAS, the District has demonstrated outstanding results on statewide assessments, NAEP-TUDA results, impressive third-grade assessment results and regularly leads the nation in both Advanced Placement (AP) participation and performance among minority students; and

WHEREAS, for the seventh straight year, the District received more national magnet merit awards than any other District, and for 2017-18 award cycle, the District received 54 magnet merit awards, an increase of 12 additional awards; and

WHEREAS, the School Board must maintain sufficient revenues to maintain high quality instruction in schools; and

WHEREAS, the District has experienced a severe shortfall in the funding provided by the Florida Legislature for the District's normal operating expenses during the current and prior fiscal years, and such shortfall negatively affects the District's ability to attract and retain high quality teachers and other instructional personnel; and

WHEREAS, the State categorical funding allocation for more School Resource Officers and security personnel and other safety and security requirements is insufficient to meet the statutory requirements and needs of the District; and

IN ACCORDANCE WITH THE CONSTITUTION AND THE ELECTION LAWS OF THE STATE OF FLORIDA, ALL DULY QUALIFIED ELECTORS OF MIAMI-DADE COUNTY, FLORIDA SHALL BE ENTITLED TO VOTE IN THE ELECTION TO WHICH THIS NOTICE PERTAINS.

All statutory references herein shall be to said statutes as they exist on the date of adoption of this Resolution and as they may be from time to time amended or renumbered, except to the extent contractual commitments would preclude application of a subsequent statutory revision or repeal.

Section 10. Severability. It is declared to be the intent of the School Board that, if any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

Section 11. Conflict. Any resolution or part thereof in conflict with this Resolution or any part hereof is hereby repealed to the extent of the conflict.

Section 12. Effective Date. Sections 1 through 2 of this Resolution shall be effective upon approval by a majority of votes cast by qualified electors in the referendum provided for herein and the remaining sections of this Resolution shall be effective immediately upon its adoption.

**MEMORANDUM OF UNDERSTANDING BETWEEN
OUR KIDS OF MIAMI-DADE/MONROE, INC. AND (NAME OF CITY)**

Our Kids of Miami-Dade and Monroe, Inc. (hereinafter “Our Kids”) and (Name of City) (hereinafter the “Name of City”), a political subdivision of the State of Florida, enter into this Memorandum of Understanding (“MOU”) to establish a protocol for Foster and Adoptive Parent Recruitment within the (Name of City). Our Kids and the (Name of City) shall be referred to herein collectively as the Parties.

Our Kids agrees as follows:

1. The Our Kids’ Recruitment Specialists will conduct recruitment presentations on how to become a Foster or Adoptive Parent throughout the (Name of City) , and provide and distribute informational brochures on (Name of City) property as permitted by the (Name of City);
2. Prior to making any recruitment presentations, the Our Kids Recruitment Specialists will work with the applicable (Name of City) Department Heads to formalize, in detail, the expectations for the presentation and recruitment efforts;
3. When requested Our Kids Recruitment Specialists will meet with (Name of City) Department Heads to provide updates on recruitment effort outcomes;
4. Our Kids is committed to providing the highest quality services to children and families;
5. Likewise, Our Kids is committed to actively involving (Name of City) employees, at all levels of the (Name of City), in recruitment efforts;
6. Our Kids is also committed to working collaboratively with the (Name of City) to provide highly qualified Recruitment Specialists who are well versed in the need for Foster and Adoptive Parents; thus providing that information throughout the (Name of City) community at large;
7. Our Kids is committed to frequent and open communication with the (Name of City) about recruitment efforts being made through the (Name of City) community at large;
8. Our Kids agrees to work collaboratively with the (Name of City) to achieve positive Foster and Adoptive Parent recruitment outcomes;
9. Our Kids agrees to share data and information regarding children in foster care and those children in need of adoptive families as permitted by law and in compliance with all applicable Florida Statutes, rules, regulations, and confidentiality restrictions.

This Memorandum of Understanding may be executed in one or more counterparts, each of which will be deemed to be an original copy of this MOU and all of which, when taken together, will be deemed to constitute one and the same MOU. The exchange of copies of this MOU and of signature pages by email transmission shall constitute effective execution and delivery of this MOU as to the Parties and may be used in lieu of the original MOU for all purposes. Signatures of the parties transmitted by email shall be deemed to be their original signatures for all purposes.

Effective date and Execution. This Memorandum of Understanding shall become effective upon the execution and delivery hereof by each of the parties hereto.
